BERNARD OLTER DOW, beloved husband, father and brother, passed away at home surrounded by his family on December 26, 2004, after a courageous and valiant year-long battle with brain cancer.

Bernie, as he was known by his loving family and many friends and colleagues, was born on August 20, 1932, to Lily and Harry Dow in Houston, Texas. He graduated with honors from San Jacinto High School in 1950. While a junior at San Jacinto, Bernie and his debate partner won the Houston Interscholastic League Debate Tournament. In 1948, Bernie won first place in the national B'nai Brith AZA Sermon Contest. His award-winning speech was entitled "The Responsibility of American Jewish Youth."

In 1959, Bernie began practicing law with his father, his older brother Melvin and his friend Ed Cogburn. A few years later, his brother-in-law, Abe Friedman, joined the firm in what later became the firm of Dow, Cogburn and Friedman, P.C. In April 2003, Bernie became Senior Counsel to the law firm of Dow Golub Berg & Beverly LLP, where he enjoyed practicing law with his son Sanford.

Bernie was a leading and well-recognized authority in real estate law. He dedicated himself not only to his loyal clients, but also to the Bar, through his tireless efforts in chairing, writing for and conducting numerous Continuing Legal Education programs, such as the State Bar of Texas' Advanced Real Estate Law Course the University

The REV. WALTER MONTGOMERY CROFTON, JR., age 74, child of the manse and great, great grandson of the pioneer Houston family of Frederick and Antoinette Schweikart died at his home in Houston on December 24, 2004. He was born in Columbus, Georgia, the son of the Rev. Walter M. Crofton, Sr. and Gladys Davidson Crofton, Sr. and Gladys Davidson Crofton. Growing up in Houston, he attended public schools, graduating from Lamar H.S. in 1949. He graduated from Austin 2052 and entered the Navy, serving as a Line Officer aboard the U.S. Navy destroyer, USS Orleck, during the Korean Conflict.

Mr. Crofton was a Presbyterian Minister, graduating from Austin Presbyterian Theological Seminary in 1962. He served pastorates in El Paso, TX, Oklahoma City, OK, Fort Smith, AR, and concluded his pastoral career as senior pastor of the Pines Presbyterian Church in Houston, TX from 1976 to his retirement in 1993. Concurrently, Mr. Crofton was re-commissioned a chaplain in the U.S. Navy Reserve, retiring with the rank of Commander in 1980. Mr. Crofton was an active churchman at both local and regional levels of the Presbyterian Church (USA). He distinguished himself as the first moderator of the Synod of Arkansas-Oklahoma in the 1960's, and as a member of the Board of Austin Seminary, chairing the Stitt Library remodeling project. Notable accomplishments include: the creation of a child day care center at his church in Oklahoma City, the first of its kind in the State of Oklahoma; working as the founding president of MAM (Memorial Assistance Ministries), a faith-based social service ministry supported by local churches helping low-income families in the Spring Branch area; and fund-raising work for Mary Holmes

Maly Neten Wolten, preceded him in death.
